

Rule 603(c)(5)(iii) of the Regulation for the Control of Atmospheric Pollution,
(Regulation No.5300, as amended), is amended to read as follow:

RULE 603 CONTENT OF PERMIT

(iii) A requirement that the compliance certification include the following:

- (A) The identification of each term or condition of the permit that is the basis of the certification; and
- (B) The compliance status. Each deviation shall be identified and taken into account in the compliance certification; and
- (C) A statement indicating whether compliance was continuous or intermittent; and
- (D) The methods or other means used for determining the compliance status with each term and condition, currently and over the reporting period consistent with sections (a)(3)-(5) of Rule 603; and
- (E) Identification of possible exceptions to compliance, any periods which compliance is required and in which an excursion or exceedance as defined under 40 CFR Part 64 (CAM) occurred; and
- (F) Such other facts as the Board may require to determine the compliance status of the source.
